Notice of an Investigation of the Proposed Acquisition of Stake in Almin Metals Industries Limited by Investors in Africa-Takura Ventures (Private) Limited and Takura III (Private) limited

IT is hereby notified, in terms of section 28 of the Competition Act [Chapter 14:28], that the Competition and Tariff Commission has commenced an investigation of a proposed merger.

The merger under investigation involves the proposed acquisition of an equity stake in Almin Metals Industries Limited (Almin) by Investors in Africa-Takura Ventures (Private) Limited and Takura III (Private) Limited. The acquirer is an investment holding firm focused on Zimbabwe that also invests in other SADC countries. Almin is an integrated construction services and supply entity created from the consolidation of four companies through a transaction which was approved by the Commission in June, 2023. The four companies which form the divisions of Almin are Almin Metals Industries Limited, City Glass and Paint Suppliers (Private) Limited, RD Architectural Aluminium (Private) Limited and Lupane Timbers Products (Private) Limited.

The Commission endeavours to determine whether the proposed merger is likely to lessen substantially the degree of competition in Zimbabwe or any substantial part of Zimbabwe or is likely to result in a monopoly situation which is or will be contrary to public interest as provided in section 34(4) of the Act. The investigation also seeks to ascertain how the merging parties and other related players operate in the market pre-merger and envisage how the merging parties will operate should the transaction be approved by the Commission.

In view of the foregoing, the Commission hereby gives notice to all interested stakeholders and the public to submit their written representatives to the Commission stating how they will be affected by the proposed merger under investigation, not later than Friday, 1st September, 2023.
